

## COMUNICADO A LAS MUNICIPALIDADES DEL PAÍS

El Ministerio de Finanzas Públicas informa que con base en lo establecido en los artículos del 118 al 122 del Código Municipal, Decreto número 12-2002 y sus reformas contenidas en el Decreto 22-2010; y al cálculo matemático aprobado por la comisión específica para el año 2014, el 14 de abril de 2014 se hará efectivo a las municipalidades del país, el Aporte Constitucional, IVA-PAZ, Distribución de Petróleo e Impuesto de Circulación de Vehículos correspondiente al mes de **MARZO** de 2,014.

Asimismo, se informa que de conformidad con el artículo 28 de la Ley Orgánica del Presupuesto, Decreto 101-97 del Congreso de la República y la literal e) del artículo 35 del Decreto 114-97 "Ley del Organismo Ejecutivo", el monto del aporte se ha ajustado de acuerdo a la recaudación de los ingresos tributarios.

La transferencia de fondos se realizará mediante acreditamiento en cuenta a través de los bancos Crédito Hipotecario Nacional -CHN- y de Desarrollo Rural, S.A. -Barrural-, para lo cual cada municipalidad deberá presentar el recibo fiscal a su respectivo banco.
