Se **INFORMA** que el Comunicado a las Municipalidades del País publicado en el Diario de Centro América el viernes 14 de febrero del presente año, en las páginas 10 y 11 sobre el aporte constitucional correspondiente a febrero 2020, es el siguiente:

COMUNICADO A LAS MUNICIPALIDADES DEL PAÍS

El Ministerio de Finanzas Públicas con base en lo establecido en los Artículos del 118 al 122 del Código Municipal, Decreto Número 12-2002 y sus reformas contenidas en el Decreto Número 22-2010, ambos del Congreso de la República; y al cálculo matemático aprobado por la comisión específica para el año 2020, informa que el 14 de febrero de 2020 se hizo efectivo a las municipalidades del país, el aporte constitucional correspondiente al mes de febrero de 2020; iva-paz, impuesto de circulación de vehículos y distribución de petróleo, correspondiente a la recaudación del mes de enero 2020.

La transferencia de fondos se realizó mediante acreditamiento en cuenta a través de los bancos Crédito Hipotecario Nacional -CHN- y de Desarrollo Rural, S. A. -BANRURAL-, para lo cual cada municipalidad deberá presentar el recibo fiscal a su respectivo banco.
